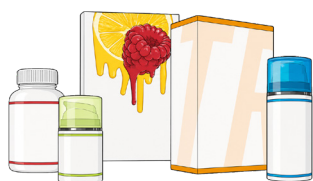

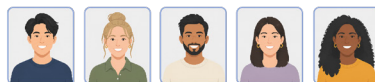

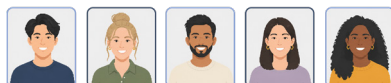

EXAMPLE EARNINGS TIMELINE

TIMEFRAME	MILESTONE	POTENTIAL BONUS
Month 1	Enroll 5 Distributors	Standard first order bonus \$100+*
Month 2	Level 1 Core 5 Qualification	\$150 product credit
Month 3+	Level 2 Core 5 Qualification	\$150 product credit + \$250 cash

**Example: Enroll 5 distributors with a Somaderm Launch Kit and receive a \$20 first order bonus per enrollment (\$100 total).*

PROGRAM FAQ

Q: Who is eligible to participate?

A: North American distributors at paid-as rank of Coach and below. Qualifying Level 1 or Level 2 customer or distributors must also be enrolled in US or Canada.

Q: What orders are eligible to count towards my Core 5?

A: All orders over 140 QV are eligible to count towards Core 5 except for enrollment orders. This includes standard orders, subscriptions and maintenance packs.

Q: When can I qualify?

A: You are eligible to qualify each calendar month. You may earn the Core 5 Level 1 and Level 2 bonuses up to two times by completing the requirements twice.

Q: Can I qualify for two Level 1 bonuses without completing my first Level 2?

A: Yes, you can qualify for two Level 1 bonuses as long as you have 10 personally-sponsored distributors or customers placing a 140 QV order within a calendar month.

Q: When are bonuses paid out?

A: Bonuses are paid out the week of the 15th of the following month. You must be commission active to receive your payout.

Q: When does product credit expire?

A: Product credit expires one year after it is issued. Products purchased with product credit will receive full QV and CV will be discounted proportionally. Product credit cannot be applied towards tax or shipping.

Q: Do enrollment orders count toward qualification?

A: No, enrollment orders do not count. You will still receive the standard First Order Bonus for enrollments. Only subsequent orders, subscriptions, and maintenance packs of 140 QV or more qualify.

Q: What if I advance to Life Coach rank mid-month?

A: Eligibility is based on paid-as rank at the beginning of the month (first Friday). If you advance to Life Coach, you'll remain eligible through the current month but will no longer be eligible starting the following month.

PROGRAM RULES

ELIGIBILITY

- I Available to Distributors at paid-as rank Coach and below.
- I Must be active and commission qualified to participate.
- I If a Distributor advances above Coach rank, they are no longer eligible beginning the following qualification month.

QUALIFICATION PERIOD

First through the last day of each calendar month (qualification month).

LEVEL 1 QUALIFICATION

To qualify for the **Core 5 Level 1 Bonus**, a Distributor must:

- I Place a personal order of 140 QV
- I Have a total of 5 Distributors or Customers each place a qualifying order of 140 QV or more within the same month (enrollment order ineligible).
- I Remain active and commission qualified through month-end.

LEVEL 1 PAYOUT

- I Earn \$150 product credit
- I May be earned each month qualifications are met.

LEVEL 2 QUALIFICATION

To qualify for the **Core 5 Level 2 Bonus**, a Distributor must:

- I Meet all Level 1 requirements.
- I Have at least 2 of the personally enrolled Core 5 Distributors who each complete their own Level 1 qualification.
- I Complete all qualifications within the same qualification month.

LEVEL 2 PAYOUT

- I Earn \$250
- I May be earned each month qualifications are met.

ADDITIONAL RULES

- I Standard orders, subscriptions and maintenance pack monthly volume over 140 QV are eligible for this promotion. Enrollment orders are ineligible.
- I Promotion valid for distributors enrolled in US or Canada only. Qualifying Level 1 or Level 2 customer or distributors must also be enrolled in US or Canada.
- I Eligibility is based on paid-as rank at the beginning of the month (first Friday).
- I Each Customer or Distributor may only be counted once toward a single sponsor's qualification.
- I Level 1 qualification is required to earn the Level 2 Payout.
- I Distributors may complete the Core 5 level 1 and/or level 2 structure up to two times per calendar month.
- I Returned, refunded, fraudulent, or canceled orders may result in bonus reversal.
- I The company reserves the right to audit qualifications and adjust payouts if errors are found.
- I Bonuses are paid out the week of the 15th of the following month.
- I This is a promotional bonus, paid in addition to the standard compensation plan.
- I The company may modify, suspend, or discontinue this promotion at any time.
